- (1) Omit information that ought to be given in this notice;
- (2) Provide information that is materially false or misleading;
- (3) Fail to provide written notification to the Council's Monitoring Officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances.
