Minutes of the Meeting held on Tuesday 2nd November 2021, commencing at 7pm Venue: The Tithe Barn, Up Street, Bardwell IP31 1AA (Bardwell Village Hall)

1. To receive apologies for absence: None

Approval for absences: N/A

- 2. To receive declarations of interests (pecuniary, local non pecuniary and personal interests). Cllr Smith: Pecuniary interest finance re Clerk/RFO salary. Cllr Smith did not vote on this item.
 - No requests for dispensations were received.
- 3. Approval of the Minutes of the meeting held 5th October 2021.

The Minutes were unanimously approved and signed as an accurate record by the Chairman.

- 4. Public participation session
- 4.1 A resident from Ixworth Thorpe Road, seeking parish council support for a reduction in the speed limit, described the rationale for his request relating to issues of motorists driving at inappropriate speeds resulting in danger caused to children, horse riders, dog walkers, and other road users. See 7.1
- 4.2 A resident requested a grit bin on the corner of The Croft/Quaker Lane.

- 4.3 Drain at bend opposite Bardwell Hall 'sits' above Highway and requires attention Contact SCC/Clerk

- 5.1 County Councillor Joanna Spicer MBE

Footbridge across River Black Bourn at Church Meadow: a report from the SCC bridges structural team is expected soon, which will identify the necessary repairs and likely length of closure. Land owner of Church Meadow to be asked whether he would be prepared to permit walkers to walk along the river in this vicinity on a temporary basis.

Clerk to provide landowner's contact details to Cllr Spicer for this purpose (SCC will write to him).

A1088: Cllr Spicer explained that there are temporary lights on the road bridge at Stowlangtoft on the A1088, which is collapsing into the river. This has impacted local HGV businesses who currently have licences to use this road.

Blocked drain at Low Street: Investigation by SCC continues to be awaited to establish cause of blockage and requisite remedial work.

Weedkilling/Verges: In response to a question, Cllr Spicer explained that SCC now only carry out weedkilling once a year on pavements due to the Green Agenda, and there is a desire to cease weedkilling completely. Similarly, verges are now only cut once per year.

5.2 **West Suffolk Councillor, Andrew Smith**: Report previously circulated - see attached.

6. Bardwell Speed watch

Cllr Compton reported that the team had carried out some sessions during October, but nothing of concern to report. The team will be out again during December.

- 7. Highways issues: Correspondence received from residents
- 7.1 **Ixworth Thorpe Road - Speeding Concerns:** A resident of Ixworth Thorpe Road sought parish council support for an extension to the existing 30mph speed limit from the junction with Church Road to a point beyond Place Farm on safety grounds. (Currently national speed limit applies). Cllr Spicer explained that the road does not meet the criteria for lowering the speed limit and therefore the chances of success are very low. The police will not normally support such requests because they don't have the capacity to enforce in such locations. If the parish council wishes to pursue the request it will initially need, and be liable for the costs of, the traffic monitoring survey (which is initially required) (£365) and all costs of the application including legal costs of implementation if successful, likely to be in the region of £1000 - £1500. Alternative options could be implemented such as road markings "Slow". A suggestion of applying to designate the road as a "Quiet Lane was also mentioned. (One resident had put this forward as a suggestion for Ixworth Thorpe Road when the QL consultation was held for Knox Lane/Davey's Lane/Wyken Road.) Response: Councillors agreed that enquiries will be made to establish the feasibility/likely chances of success and costs of an application to Suffolk County Council, for an extension to the existing 30mph limit from the junction with Church Road to a point beyond Place Farm. The outcome of the enquiries will be discussed at the December meeting. Cllr Compton will investigate the possibility of using the VAS along Ixworth Thorpe Road.
- 7.2 **School Lane: Parking issues** were discussed, following correspondence and photographs received from a resident (previously circulated to councillors). Drivers dropping off/picking up children at the school and also those visiting the Windmill bakery are asked to park appropriately at all times to avoid causing difficulties for other road users. Parking on the pavement/kerb results in difficulties/danger for pedestrians, particularly disabled people or parents with push chairs who are forced to walk into the road and around the vehicles. It is an offence for vehicles to park on the pavement if they are causing an obstruction.

Resolution: It is believed that that several vehicles regularly parked during the day in School Lane belong to staff members. It was suggested that if staff could park in the Tilian House car park that this would provide extra capacity for other motorists. The Chairman will monitor the vehicles parked during the day in School Lane, following which a letter will be sent to the Head teacher.

10. Planning

- 10.1 DC/21/1999 EIASC Scoping The parish council has previously confirmed its agreement that scoping opinion is required, it will now submit the details of what it considers should be included. The majority of councillors raised no objections to the following applications and therefore the parish council response submitted to West Suffolk Council planning department stated No comments/no objections:

- 11.2 **Proms concert on the playing field:** This is a possibility but would take considerable organising. Has the resident who has made the suggestion realised that they would be required to 'take ownership' and responsibility for organising the event?
- 11.3 The Chairman has written to Michelle Boyd, deputy head of Bardwell School, who has expressed a keen willingness for the school children to be involved in local celebrations. Further information awaited.

Deadline 17th December 2021, particularly being mindful of the impact that the closure of the A143 has at anytime there is an accident, resulting in lorries travelling into/through the village.

A decision regarding a proposal to transfer this asset to the parish council from the BPFA was deferred to the December meeting pending further information to include the ongoing liability/how the asset would be managed: value of the asset, maintenance and impact on the 'public purse' (potential precept increase).

The individual items of play equipment were briefly discussed and various concerns/questions asked: particular concern was raised about the roundabout.

It is noted that there is a monthly inspection carried out by a qualified person from WSC and a more detailed annual report by an independent surveyor: The reports are circulated to councillors.

The BPFA has been extremely effective at maintaining the play equipment to-date.

District Councillor Parish Report Tuesday 2 November 2021

As you may have seen in the press Suffolk has just been granted the extra national resources that it asked for to help fight the rising number of cases of COVID-19 that we are facing. By way of some further detail:-

The Leader of West Suffolk District Council was involved in the Suffolk Local Outbreak Engagement Board discussions that backed this request to Government and was on the call with the Parliamentary Under-Secretary of State for Vaccines and Public Health Maggie Throup when the additional support, funding and resources to help the NHS avoid unsustainable pressure, were agreed.

The additional support includes:_

- Extra localised COVID-19 testing, often known as 'surge testing'
- Logistical support to maximise vaccine take up and help deliver door knocking campaigns
- Additional control measures in schools
- Communications funding and support
- Fast tracked escalation of issues through the Government's emergency response decision making processes

The move sees Suffolk, alongside Cambridgeshire and Peterborough become an 'enhanced response area' (ERA) for up to five weeks as has already been used in other parts of the country to help reduce the rate of COVID-19 transmission within the community.

It should be noted that the ERA support is on top of the measures already introduced to slow the spread of the virus, particularly in schools.

These latest measures do not bring any additional restrictions on people's movements or actions. It is not like the tiering system that was trialled in England in 2020. Instead, it will boost the county's ability to raise awareness, tackle outbreaks and encourage people to get vaccinated.

All the hedges around both the overflow carpark and the playing field have been cut during the last two weeks. Thanks are due to all the volunteers involved in completing this work.

It is planned to improve the hedge on the roadside by laying it in the traditional manner. This will benefit wildlife when the hedge grows next spring as well as reduce the shading on the MUGA court that causes the playing surface to be quite slippery when wet. The court has been pressure washed recently which has also reduced that problem.

The firework display will take place next Friday. Sponsorship has been kindly provided by several organisations with operations in the village together with the grant provided by the Parish Council.
